

LEASE LOUNGE LIMITED T/A PLAYERS CARS
COMPETITION TERMS AND CONDITIONS
MAGALUF PRIZE DRAW 2019

1. THE PROMOTER

The Promoter is: Lease Lounge Limited T/A Players Cars of 110 Gelderd Road, Leeds, West Yorkshire LS126BY

2. THE COMPETITION

2.1 The title of the competition is the Magaluf 2019 Prize Draw ("**Prize Draw**").

2.2 The Prize Draw is open to:

2.2.1 anyone who purchases a motor vehicle from the Promoter during the Promotional Period, and they will be automatically entered into the Prize Draw; and

2.2.2 anyone who submits an entry in accordance with clause 3.4 below.

3. HOW TO ENTER

3.1 The competition will run from 3rd May 2019 on (the "**Opening Date**") to 1800 GMT on 26th May 2019 (the "**Closing Date**") inclusive (the "**Promotional Period**").

3.2 All competition entries must be received by the Promoter at the address set out at Condition 1 by no later than 0900 GMT on the Closing Date. All competition entries received after the Closing Date are automatically disqualified.

3.3 NO PURCHASE NECESSARY.

3.4 To enter the competition:

3.4.1 complete the purchase of a motor vehicle from the Promoter during the Promotional Period – anyone doing so will be automatically entered into the Prize Draw and unless expressly stating that they do not wish to be entered into it.

3.4.2 send a letter or piece of paper stating that you wish to be entered into the Prize Draw, by first or second class post to Lease Lounge Limited T/A Players Cars of 110 Gelderd Road, Leeds, LS12 6BY, clearly stating on the envelope PRIZE DRAW ENTRY, by the Closing Date.

3.4.3 Like our Instagram post with any post titled Magaluf and tag 2 other Instagram users.

3.5 The Promoter will not accept:

3.5.1 responsibility for competition entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any postal failure, equipment failure, technical malfunction, systems,

satellite, network, server, computer hardware or software failure of any kind; or

3.5.2 proof of posting or transmission as proof of receipt of entry to the competition.

3.6 By submitting a competition entry, you are agreeing to be bound by these terms and conditions.

3.8 The winning entry will be selected at random, using randomising software by an independent party i.e. one that is not connected to the Promoter.

4. ELIGIBILITY

4.1 The competition is only open to all residents in the UK aged 18 years or over, except:

4.1.1 employees of the Promoter or its holding or subsidiary companies;

4.1.2 employees of agents or suppliers of the Promoter or its holding or subsidiary companies, who are professionally connected with the competition or its administration; or

4.1.3 members of the immediate families or households of 4.1.1 and 4.1.2 above.

4.2 In entering the competition, you confirm that you are eligible to do so and eligible to claim the prize. The Promoter may require you to provide proof that you are eligible to enter the competition.

4.3 The Promoter will not accept competition entries that are:

4.3.1 automatically generated by computer;

4.3.2 completed by third parties or in bulk;

4.3.3 illegible, have been altered, reconstructed, forged or tampered with;

4.3.4 photocopies and not originals (although photocopies of the entry form itself are allowed); or

4.3.5 incomplete.

4.4 There is a limit of one entry to the competition per household. Entries on behalf of another person will not be accepted and joint submissions are not allowed.

4.5 The Promoter reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize competition.

4.6 Competition entries cannot be returned.

5. THE PRIZE

5.1 The prize consists of:

- 5.1.1 A flight for three people from Manchester Airport to Palma International Airport on 25th June 2019.
- 5.1.2 A flight for three people to Manchester Airport from Palma International Airport on 27 June 2019
- 5.1.3 Two night stay in a double or twin room at the BH Mallorca Adults Only Hotel– room only.
- 5.2 The flight is non transferable
- 5.3 The holiday is for three people, one of whom must be over the age of 18, to travel by standard class to palma for two nights between 25th June 2019 and 27th June 2019 The prize does not include travel insurance, the cost of transfers to and from airports or stations, food and drink, spending money, tax or personal expenses. Any other costs incurred in addition to those set out above and that are incidental to the fulfilment of the prize are the responsibility of the winner.
- 5.4 You will be responsible for ensuring that you and any person travelling with you are available to travel and hold valid passports, any necessary visas (including the ESTA Visa if required) and travel documents for the holiday in question on the travel dates specified.
- 5.5 If you are unavailable on the dates specified then you should inform the Promoter immediately. You will not be offered a cash alternative for the prize.
- 5.6 The prize is not negotiable or transferable.
- 5.7 In order to claim the prize you must contact the Promoter within twenty four hours of being informed that you have been selected.
- 6. WINNER ANNOUNCEMENT**
- 6.1 The winner of the competition will be announced on the Promoters website and the competition website and via social media (including but not limited to Facebook, LinkedIn and Twitter) on 26th May 2019 (“**Announcement Date**”).
- 6.2 The selection of the competition winner is final and no correspondence or discussion will be entered into.
- 6.3 The Promoter will contact the winner personally as soon as practicable after the Announcement Date, using the telephone number or email address provided with the competition entry. The Promoter will not amend any contact information once the competition entry form has been submitted.
- 6.4 The Promoter will send the name and county of the winner to anyone who writes within one month after the Closing Date of the competition requesting details of the winner and who encloses a self-addressed envelope to the address set out in Condition 1.

7. CLAIMING THE PRIZE

7.1 If you are the winner of the prize you will have five days from the Announcement Date to claim the prize by contacting the Promoter by email, telephone or letter. If you do not claim the prize by this date, your claim will become invalid.

7.2 The prize may be claimed by a third party on your behalf.

7.3 The Promoter will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available, or has not claimed their prize within five days of the Announcement Date, the Promoter reserves the right to offer the prize to the next eligible entrant selected from the correct entries that were received before the Closing Date.

7.4 The Promoter does not accept any responsibility if you are not able to take up the prize.

8. LIMITATION OF LIABILITY

Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.

9. OWNERSHIP OF COMPETITION ENTRIES AND INTELLECTUAL PROPERTY RIGHTS
